B. WATER

Water usage rate is as follows:

1. 3/4" meter	base rate	\$13.84 per month	
2. 1" meter	base rate	\$24.63 per month	
3. 1-1/2" meter	base rate	\$55.35 per month	
4. 2" meter	base rate	\$98.39 per month	
5. 3" meter	base rate	\$221.39 per month	
6. Usage rate of \$0.83 per one thousand gallons of water.			

7. Outside city limits 125% - 1.03

Any hookup to the city water system will pay the base rate for the size of the hookup line. Any additional units using that line will be charged the base rate of \$13.84.
