# MINUTES OF PUBLIC HEARINGS & REGULAR MEETING SUGAR CITY COUNCIL THURSDAY, SEPTEMBER 14, 2023

Public Works Director Arlynn Jacobson was excused.

### **CONSENT AGENDA:**

**MOTION:** It was moved by Councilwoman Ball and seconded by Councilwoman Nielsen to approve the Consent Agenda; motion carried.

SUGAR CITY AREA HISTORICAL SOCIETY: Co-President Grant Johnson addressed the council about the goals and needs of the newly formed 501(c)(3). They are currently seeking a place for the museum and donations. The city is supportive and will continue to donate \$5,000 to the society annually. City Attorney Chase Hendricks encouraged them to set up their own bank account and become independent of the city. Planning and Zoning Administrator Kurt Hibbert spoke of how Leadore, Idaho established their \$900,000 museum by leveraging \$5,000 seed money. Below is a summary of their needs and goals:

- 2000 sq ft display area
- 2000 sq ft storage space
- New or renovated building that meets ADA standards
- Parking
- Visibility
- Gift shop
- \$50,000 in donations by end of year

**TENNIS COURTS:** Jason Flaig asked the council to support and authorize a committee to build six new city tennis courts through a possible 50% matching funds Parks and Recreation grant through the city. The grant is due August 2024 but the first workshop for the grant is September 23, 2023. The school district has expressed an interest to the council through their student leadership as well. Needs/Benefits, goals, and concerns are summarized below:

Needs/Benefits:

- City is growing and increasing in size
- High School enrollment is 590 students and could be a 4A classification district soon (student enrollment between 640 and 1300)
- Tennis is the fastest growing program in the area with many benefits to students and

families

- Six courts would allow tournament matches and increase city revenue
- Current courts are in bad condition and a liability to the city

#### Goals:

- Six cement (PT) tennis courts \$853,000 (56-year lifetime) or six asphalt tennis courts \$600,000 (20-year lifetime and more expensive because of future maintenance and replacement costs)
- \$600,000 Parks and Recreation Grant 50% matching funds
  - o \$150,000 plus donations
  - o City and school share \$150,000 match
- \$253,000 other donations and funding or needed for future maintenance and replacement costs if choosing asphalt courts.
- Joint committee and support of Sugar Salem High School

#### Concerns:

- Timeline and deadlines
- Location
- Type of courts
- Funding
- Parking
- Current liabilities
- Future maintenance costs
- School district participation

**MOTION:** It was moved by Councilman Dayley and seconded by Councilwoman Ball to appoint and authorize a committee to pursue the grant; motion carried.

The mayor appointed Jason Flaig as committee chairman; Molly Peterson, Alan Begley, and Jeff Wheeler volunteered from the audience. Public Works Director Arlynn Jacobson and Planning and Zoning Administrator Kurt Hibbert will also be invited to the meetings along with the mayor. The committee will seek at least one representative from the school district and will field questions of the council as needed.

Meanwhile the city will shutter the dilapidated tennis courts in Neibaur Park. Those who still want to use them will have to sign a waiver. The tennis courts and skate park in Smith Park will be torn out.

## **PUBLIC COMMENTS:** Summarized below:

**Kurt Hibbert:** The tennis courts should be city owned for public use with a maintenance agreement between the school district and the city.

**Derik Taylor:** The current condition of the tennis courts is a huge liability to the city. Brigham Young University Idaho (BYUI) suffered a million-dollar lawsuit for an injury on tennis courts in better condition than that of the city's courts.

**Jake Henry:** He grew up in Sugar City and is grateful for the positive environment and opportunity he had to participate in tennis.

### PLANNING AND ZONING REPORT:

Planning and Zoning Administrator Kurt Hibbert reported on the following items:

**Annexations:** There are five areas – islands and peninsulas that Mr. Hibbert is working with Planning and Zoning to annex into the city. Two of those have petitioned the city for annexation.

**Brownfield Clean-up:** Mr. Hibbert is working with Jake Call on a Phase One Environmental cleanup for the former Moody Creek Produce site.

**Proposed North Sugar City Development:** Mr. Hibbert is working with a business to development the north part of Sugar City. An Urban Renewal District would benefit this area and other areas within the new Regional Commercial zone. The city would need an election with a simple majority for the district.

**Proposed Impact Area Agreement:** The County held their public hearing and adopted the agreement. It is now scheduled for a public hearing with the Sugar City Planning and Zoning next week.

PUBLIC WORKS REPORT: Public Works Assistant Cody Cureton reported on the following items.

**Scada:** The city is still waiting for the new SCADA system to be completed on the new well. It is close but other mitigating circumstances have delayed the completion of the project.

**Sewer Manhole Replacement Project:** Scheduled for Monday next week. Dickinson will shut down for the repair which shouldn't take longer than a few hours.

7<sup>th</sup> West Connection to 5<sup>th</sup> South: Crews are working on the 7<sup>th</sup> West Connection to 5<sup>th</sup> South. The power pole that is obstructing the road is scheduled to be removed soon.
