#### Approve Minutes

# Public Hearing: Sugar City - Madison County Impact Area Agreement

Administrator Hibbert presented the Impact Area Agreement and went over the zoning map. He indicated that Sugar worked with other cities, like Teton, to avoid overlapping areas to avoid future conflict. He explained that engineering approval will be required for any decision that could impact ground water.

When asked about the wording of the agreement, and whether or not it was precise enough, Administrator Hibbert explained that the document allows for diplomacy to have it's proper place without restricting the existing legal processes. The commission did move to have some of the wording updated for clarity.

Motion: I move that the impact area agreement wording is modified to create consistent language throughout the document clarifying that "Sugar City" means the "city council".

Motion made by Commissioner Haacke. Seconded by Commissioner Williams. Motion Carried.

#### Deliberations

The commission discussed the agreement and moved to recommend the agreement to City Council.

#### **Future Annexation**

Administor Hibbert indicated that GIS maps are being updated in all the projected annexation areas and should be finished within the week. These are the areas discussed in the previous Planning and Zoning meeting.

### East Corridor Parkway

The commission discussed the need for a beltway road to be built that acts as a levee or dike and pushes the flood plain away from the city. The county engineer is working to update an old model that can be used as federal funding is requested.

## Design Review

Commissioner Williams gave an update on a recent design review meeting. Designs were reviewed and approved for two new business park buildings. The Sugar-Salem bus

maintenance building will be just west of the Junior High School. Some discussion took place around the location of future roads in the area - but the city is currently working with the school district to find a solution.
