Hearing - Special Use Permit Application - Right Angle Group/Three Peaks Plumbing

This application requested warehouse use for the building located at 140 Sugar Ave. by Right Angle Group/Three Peaks Plumbing, parcel RPSSUGBP110050 as recorded with Madison County.

Staff Report

Administrator Hibbert received no other input from the public. He expressed that the applicant feels the need to request a special use permit is unnecessary.

Applicant - Three Peaks Plumbing Inc. - Shayne Rammell

The applicant indicated that their company built their building in the business park. The building has two sections. One half if being rented out. The other side is being used only to store plumbing equipment. It will probably be used for family gatherings.

It was brought to his attention that warehousing usage requires a special use permit in our current code.

He indicated that he's been working hard to make his building and surrounding landscaping look nice and that other businesses in the business park are not.

He said that he's had some difficulty applying for the special use permit and getting the process to move forward. He said it's difficult to get the inspector to come to the building and that the city has been slow to work with.

New Rural Ranchette Zone

Commissioner Hawkes suggested starting with 4 cows/horses and 4 sheep/goats/pigs per acre. The commission discussed the impact of different animals on different acreage.



Motion: I move to recommend to city council to approve the Rural Ranchette proposed zone with the following conditions:

The Animal Rights section is modified to only allow 2 cows/horses per acre AND 4 sheep/goats/pigs per acre

Administrator Hibbert met with the county commission. The county indicated that they would support an amendment to the impact area agreement to include the area just north of the new LDS temple across the highway. The commission will take a proposal to them (with city council approval) to review.

Motion: I move that we write a letter about the impact area amendment request to be presented to the city council and recommend that it is presented to the county commission. I move that we recommend to the city council that they do the same.
